

Direction of the Country: Would you say that things in **America** are going in the right direction, or has the country fundamentally gotten off on the wrong track?












Governor Shapiro saw a net negative 5-point decline in sentiment among registered voters in the state since last quarter; now matching his lowest approval rating since his first quarter in office.

Governor Josh Shapiro Accomplishments: Do you feel Governor Shapiro delivered major accomplishments during his first year in office?






PA House of Representatives Favorability






Generic Presidential Ballot: If the 2024 presidential elections were held today, how would you vote if your options were between a Republican or Democratic candidate?





The generic Democratic congressional candidate and generic Republican margins narrow, in this, the last Common Ground State of the State poll released prior to November 5th.




While sentiment on the Republican party's economic policies improved over the last few months, so too has sentiment regarding Democratic economic policies, bringing this issue within the margins of error.




President Joe Biden Job Approval




President Biden's job approval remained static over the past quarter, with still over half of registered voters in the state disapproving of the job he is doing as President.


President Joe Biden Favorability




Vice President Kamala Harris Favorability



U.S. Senator Bob Casey Favorability




U.S. Senator John Fetterman Favorability




Federal Entity Favorability








Thought About Leaving PA: Have you or someone you know thought about leaving Pennsylvania for a different state due to Pennsylvania's policies?





Personally Better Off: Would you say that you and your family are financially (ROTATE) better off, about the same, worse off (END ROTATE) as you were two years ago?




Inflation Impact: How much has inflation and recent price increases impacted you or your household's ability to maintain your standard of living?




PA Economy: How would you rate the economic conditions in Pennsylvania today?




Pennsylvania's economic sentiment improves ever so slightly from Q2 (net positive 1-point), yet still underwater by 21 points. **PA State of Business:** Do you think the state of Pennsylvania is worse for businesses than it was 10 years ago, about the same for businesses than it was 10 years ago, better for businesses than it was 10 years ago?



For the third quarter in a row, Pennsylvanians sour on Pennsylvania's handling on businesses, with now 48% thinking the state is worse for business than it was 10 years ago, to only 13% who think it is better. **PA Job Situation:** Thinking about the job situation in Pennsylvania today, would you say that it is now a good time or bad time to find a quality job?




Budget Agreement: How important is it to you personally that leaders in Pennsylvania of all political parties come together and pass a budget agreement that is bi-partisan?






2023 School Ranking: How would you grade the quality of Pennsylvania's K-12 school system?







Methodology

- Online survey conducted among (2023 Q1: n600, 2023 Q2 and later: n800) registered Pennsylvania voters statewide. Respondents were selected randomly from opt-in panel participants.
- Sampling controls were used to ensure that a proportional and representative number of respondents were interviewed from such demographic groups as partisanship, age, gender, race, and geographic region.
- Statewide survey of registered voters has a ± 3.46% overall margin of error at the 95% confidence interval.
